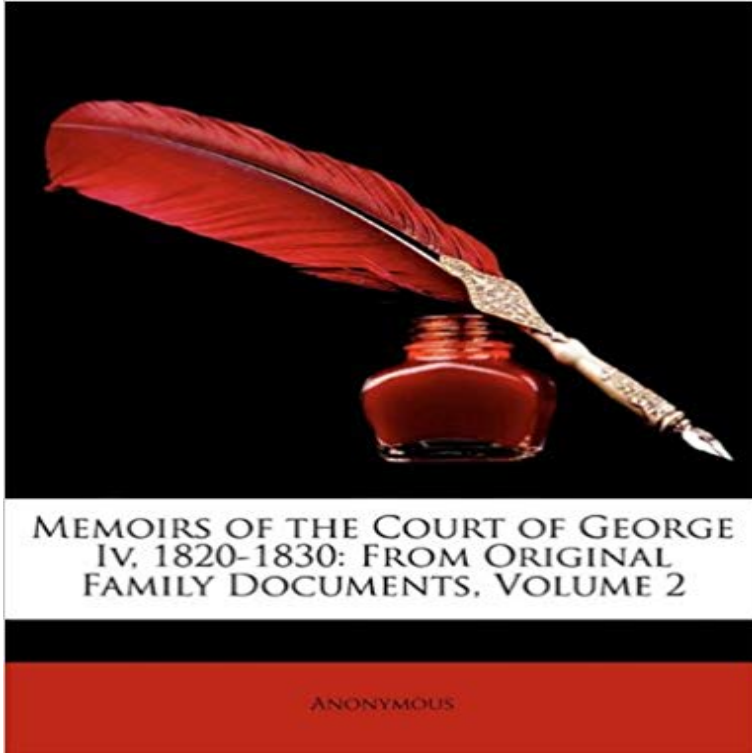


## Memoirs of the Court of George IV, 1820-1830: From Original Family Documents, Volume 2
