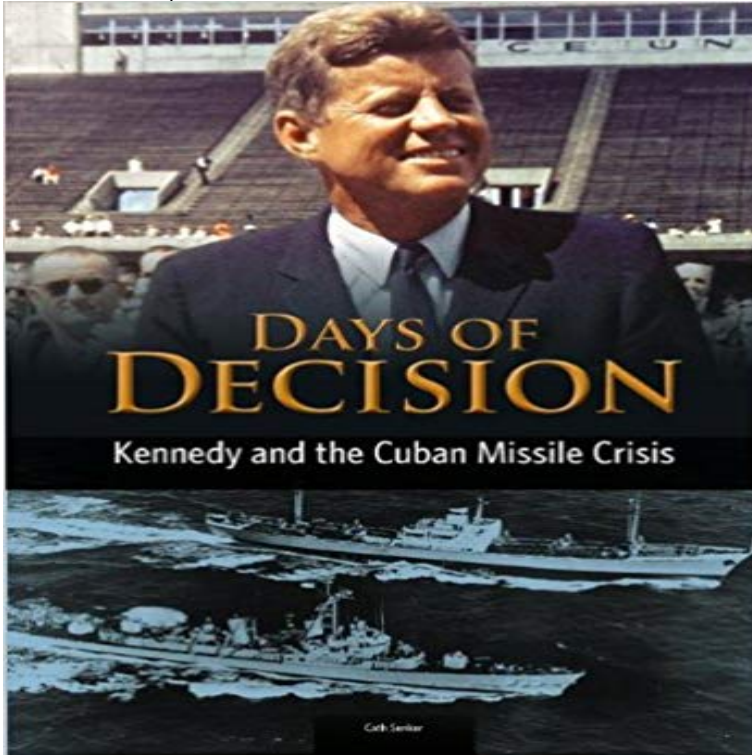


## Kennedy and the Cuban Missile Crisis: Days of Decision
