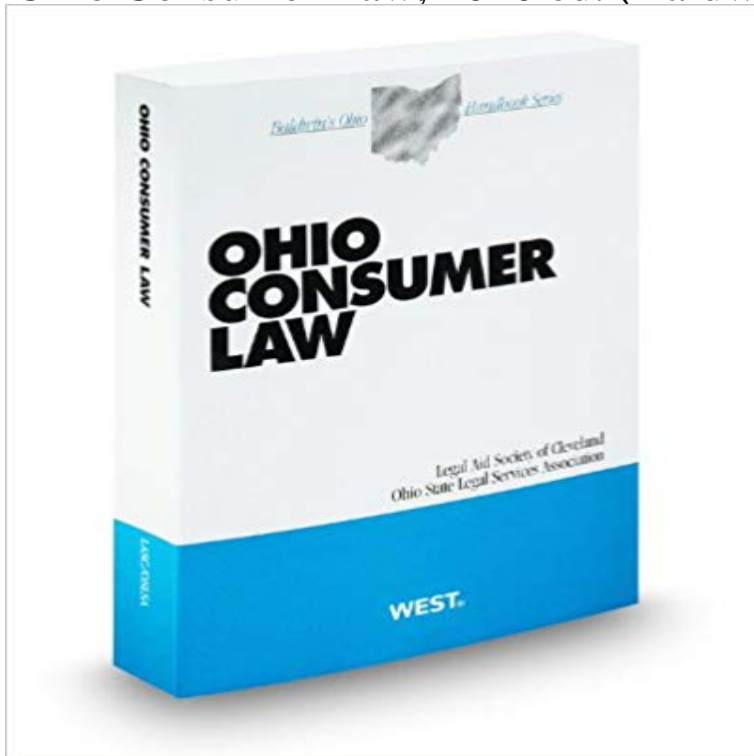


Ohio Consumer Law, 2010 ed. (Baldwins Ohio Handbook Series)
