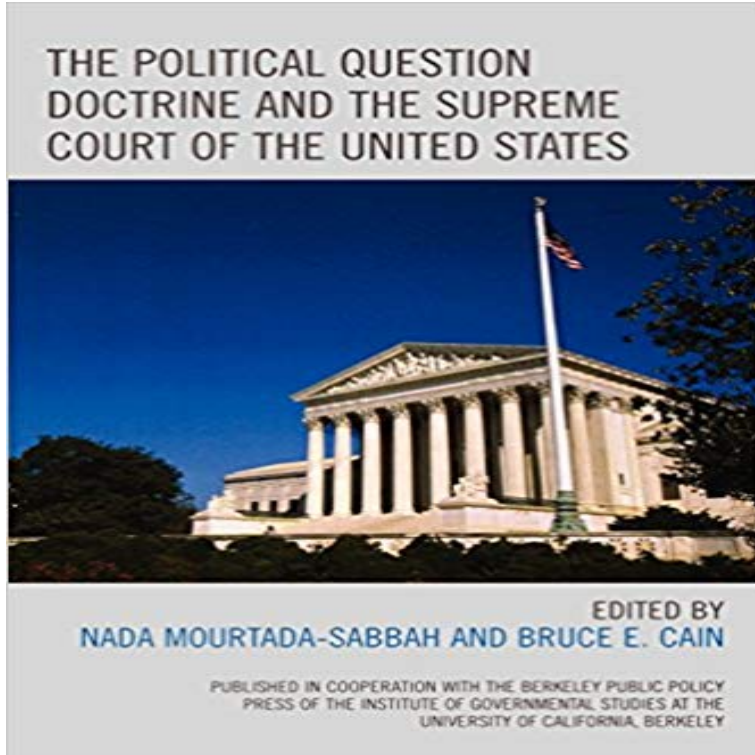


# The Political Question Doctrine and the Supreme Court of the United States
