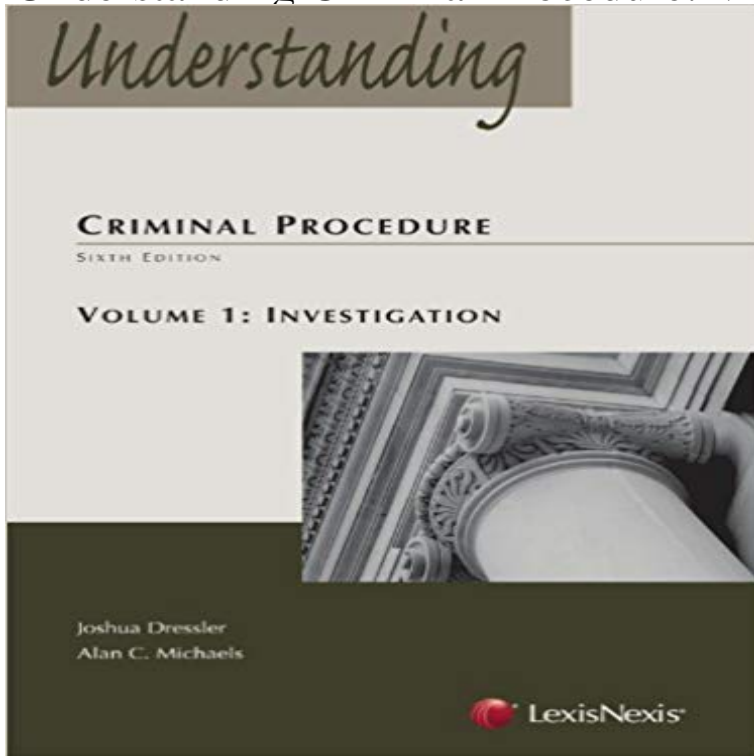


Understanding Criminal Procedure: Volume One, Investigation
